# **Privacy Policy**

## Privacy and Cookie Policy

This Privacy Policy for personal data (hereinafter referred to as the Privacy Policy) applies to all information that the website located at the domain name infiplay.site (hereinafter referred to as the Website) may receive about the User during the use of the Website's programs and products.

#### 1. Terms and definitions

1.1. In this Privacy Policy, unless otherwise expressly stated in the text, the following terms shall have the meanings indicated below: - "Administrator" - organizes and (or) carries out the processing of personal data, and also determines the purposes of processing personal data, the composition of personal data subject to processing, actions (operations) performed with personal data. - "Personal data" - any information related directly or indirectly to a specific individual (subject of personal data). - "Processing of personal data" – collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, depersonalization, blocking, deletion, destruction of personal data using automation tools. - "Confidentiality of personal data" is a mandatory requirement to prevent the dissemination of personal data without the consent of the subject of personal data or the presence of another legal basis. - Site User" is a person registered on the Site.

#### 2. General Provisions

2.1. The User's use of the Site constitutes consent to this Privacy Policy and the terms of processing the User's personal data.

2.2. In case of disagreement with the terms of the Privacy Policy, the User must stop using the Site.

2.3. This Privacy Policy applies only to the specified Site. The Site Administrator does not control and is not responsible for third-party sites that the User may access via links available on the Site.

## 3. Subject of the privacy policy

3.1. The User gives his consent to the Administrator to process personal data provided during registration, as well as information provided by the User in the Personal Account after registration.

3.2. The processing of personal data is carried out for the purposes of:

- identification of the User registered on the site to provide him/her with access to the personalized resources of the Site;

- providing the User with feedback when using the Site;

- providing the User with effective customer and technical support in the event of problems related to the use of the Site;

- sending informational and advertising messages to the e-mail address specified by the User during registration;

- analyzing and improving the operation of the Site, including the use of web analytics services

3.3. The processing of the User's personal data is carried out for the period necessary to achieve the purposes of their processing. The storage of personal data ceases upon deletion of the User's Personal Account or upon expiration of the period

3.4. The User may revoke consent to the processing of personal data at any time by sending the Administrator a corresponding notification by e-mail to

admins@infiplay.site from the e-mail address to which the User account is registered. 3.5. The User agrees to receive informational notifications. Consent can be revoked at any time through the settings in the Personal Account.

3.6. The Site uses Cookies and web analytics services. Cookies are used to identify the User's device, store settings and analyze traffic.

3.7. The Site also integrates with third-party authorization services

# 4. Guarantees

4.1. The Site Administrator uses personal data solely for the purposes specified in paragraph 3.2.

4.2. The Site Administrator takes measures to protect the User's personal data from unauthorized access, modification, destruction, and distribution.

# 5. Final Provisions

5.1. The Site Administration has the right to make changes to the Privacy Policy. 5.2. The new Policy comes into force from the moment of posting on the Site, unless otherwise provided.
